• COVID-19 ENTRANCE PROCESS

We were recently advised of some changes to the questions that are asked upon entry to all GM facilities. As the CDC updates Covid-19 protocol, General Motors is obligated to review and change processes as required. It is important that we read these questions off the signage at the temperature scanning stations, and answer each question individually. This is important, so no one mistakenly walks onto the factory floor who shouldn't be on the factory floor, for obvious reasons.

We have informed the company that the individuals who are responsible for working these entrance stations should also be made aware of these changes, to ensure these questions are being asked correctly. In the event the answer is yes to one of the questions, this individual would then be directed to medical for further evaluation. Unfortunately, this pandemic is still very much affecting our workplace here at FWA and the rest of the country. The continuation of protocol for social distancing and the proper use of our masks is a given and a requirement. Below are the up to date questions. These questions apply both prior to coming to work and once again when we enter the workplace.

Entrance Procedures

Before coming to the workplace each day, please pay attention to how you're feeling. Your safety and the safety of those around you depends on a personal self-assessment and self-reporting of any symptoms.

If you can answer YES to any of these questions:

1. Do you have symptoms associated with COVID-19 such as fever, chills, cough, fatigue, headache, sore throat, diarrhea, muscle/body aches, new loss of taste or smell, congestion or runny nose, nausea or vomiting, shortness of breath or difficulty breathing?
2. Have you had close contact with or cared for someone diagnosed with COVID-19 in the last 14 days?
3. Are you awaiting the results of a COVID-19 test?

PLEASE DO NOT REPORT TO WORK. NOTIFY YOUR SUPERVISOR OR CALL THE SITE'S ABSENCE LINE AND CALL MEDICAL AT 1-800-814-3390 OR 1-313-667-1308.

Calling allows our medical staff to gather information and provide guidance regarding the suspected or confirmed case of COVID-19 to help you.
