The President's Report

The company along with Ford and GM has decided not to put out monthly sales reports. That being said, I do have some information to share with our membership. For June 2019 and the 2nd quarter of the year, we know America loves its trucks. FCA reported that we were up two percent with Ram 1500 light-duty, 2500 thru 5500 chassis soaring 45 percent in a slow market. FCA sold 206,083 vehicles in June which has risen two percent from 2018. Jeep sales fell 12 percent, Dodge is down 17 percent and Chrysler brand fell 4 percent. That being said the Jeep Grand Cherokee was the company's best-seller in June. The Jeep Gladiator continues to take more of the market share in the mid-size truck arena. There had been some talk from GM to abandon their plans to build an SUV that would compete with the Wrangler Unlimited. That plan for the SUV was canceled in November when GM hatched a restructuring that would slash 15 percent of North American jobs (8,100) and closing down five plants.

New vehicle sales are falling across the globe not just here in the USA. With global emission rules becoming stricter and trade wars, this is hurting vehicle sales in the world market. Automakers worldwide have relied on China, the world's largest auto market, a market that has been declining for 13 straight months. The EV market has dropped 4.7 percent after the government lowered subsidies for electric vehicles and phasing out the incentives completely by 2020.

As anticipated there is a continuing dialog between FCA and Renault. CEO Manley said FCA is still open to opportunities. He made it clear that there is a strong business plan in place that survives with or without a merger. I don't have enough information to judge one way or the other, especially with the China auto industry slowing down. I assure you, your leadership is watching the auto companies. I recently read where ZF transmissions, our number one competitor, maybe in some financial troubles. Hopefully, that turns into a gain for us in the hybrid arena.

We have exchanged demands with the company to start our local agreement negotiations. Rest assured, your voices have been heard. This being my first time at the table, I feel very confident



with our very experienced Bargaining Committee. Much time was put into the proposals received from you the membership. Our goal is to unify the plants; four plants and one UNION. Sounds easy, but it is not. I want you, the membership to know there is no back down from this Bargaining Committee. Each member of the committee has areas of expertise with one common goal which is to get our membership the contract and justice you deserve. We need you, the membership to be the best union members you can be. Negative comments on social media networks will only give an advantage to the company. The company will continue to do the things they do, don't fall for the B.S. All we have to do is come to work and do our jobs. There will be supervisors trying to trip you up. Don't let them divide us. They want us fighting among ourselves. We are better than that and there is no room for snitches in Local 685. Thank you for allowing me to be your President.

What is the UAW Constitution?

The Constitution of the UAW is the supreme law of our union and is the Constitution of every affiliated subordinate body (local unions). It provides the foundation for the day-to-day operations of our great union, and equally important, it sets forth the rights, guarantees and responsibilities of all UAW members.

How do you read it?

Our UAW Constitution begins with a Preamble, which is an introduction to our union and core values. If you're a new member, you should pay extra attention to the Preamble and Article 6, "Membership" and Article 41 "Duties of Local Union Members".

The body of our UAW Constitution is broken down into Articles and Sections. An Article being a main subject and each Section underneath the Article a key point related to that subject.

Start by reading the Constitution front to back, but after reading each Article, flip to the very back of the Constitution to see if there is an interpretation for that Article. The interpretations are key clarifications. They represent the interpretations of our Constitution by the International Executive Board.

Pay special attention to the Ethical Practices Codes, found after the Articles.

What if you have questions about it?

You can seek assistance from your Constitution and Bylaws Committee and/or Local Union Leadership.

When Local Union leaders have a question regarding the Constitution, they should contact their Servicing Rep or Regional Director.



First, I hope everyone has enjoyed the summer as we are now going into the fall season. Everyone knows that our 2019 National Agreement ends on September 14, 2019. Our National Bargaining Committee is working hard at trying to restore the division, equality, justice and bring us a good lucrative contract that we can all prosper from while our brothers and sisters build the best transmissions in the world right here in Kokomo and

Tipton, Indiana. I would like to thank Committeeman Matt Jarvis for serving on the National Bargaining Committee who has experience in helping negotiate the Local 685 agreements in the past three contracts.

The eight-speed transmission at KTP continues to hit on all eight cylinders with the high demands from FCA having record sales from our trucks and SUVs in the 2nd quarter of this year. The nine-speed should be bouncing back after the new Voyager Van goes into production in 2020. This will eliminate the Dodge Caravan in Windsor, Canada. Here at ITP II, we continue to move equipment out in hopes of a new product coming in. The Felsomats at ITP II are being moved to ITP I with the first set of machines being moved around August 12th or 19th and the second set to go on or around October 7, 2019.

FCA is still planning on making ITP II a MLM distribution center or what you would call a warehouse. I know our National Bargaining Committee has every intention of bringing in new product or products to Kokomo to fill ITP II and any other space that is available. Our Local 685 Bargaining Committee keeps driving management to bring work to our community. As we move into a new National Agreement, our Local Bargaining Committee will begin on the Local 685 agreement.



Our first guest speaker was Mr. Robert Roach, President of the Alliance for Retired Americans (ARA) and former General Secretary-Treasurer of the International Association of Machinists and Aerospace Workers (IAM). Brother Roach discussed the current political climate, what is at stake for seniors, and the work being done by ARA to ensure economic stability for seniors.

Rich Fiesta, Executive Director of ARA spoke on the current attacks on entitlements such as Social Security and Medicare, as well as the risk faced by multi-employer pension funds. The average working household has virtually no retirement savings. Four out of five households have less than one times their annual income in retirement savings and the numbers are even lower for Black and Hispanic families. Social Security is the primary source of income for 75 percent of retirees. When it comes to the African-American Community Social Security provides 90 percent of the total income for more than half (55 percent) of African-American elderly people. Threats to Medicare Benefits include:

- Raising the age of eligibility
- Voucher and Privatization
- Means-Testing
- New Chained CPI proposal

In regards to pensions, Mr. Fiesta shared the following:

- 100 plus multiemployer pension plans are at risk of insolvency
- 1.5 million retirees could lose benefits
- The Pension Benefit Guaranty Corporation (PGBC) Multiemployer Insurance Fund, which protects about 10.6 million workers and retirees in about 1,400 private-sector denied benefits pension plans, could go bankrupt by 2025
- If multi-employer fund fails, the collapse of PBGC Multiemployer Insurance Fund would have an impact on the 28M single employer and 10M multiemployer beneficiaries also included under the PBGC
- H.R. 397, the Rehabilitation of Multiemployers Act, would provide loans to financially troubled plans

The information provided by Brothers Roach and Fiesta was informative and should motivate, not only retirees but every worker to become involved with the work being done by ARA. The retiree committee urges every CBTU member to lean more, join and or work with the ARA Chapter in their area.

A panel discussion titled, "Reclaiming Our Time" featured President Emeritus Bill Lucy, Former CBTU National Treasurer Royetta Sanford and Robby Sparks, President Emeritus of the Electrical Workers Minority Caucus (EWMC). Ms. Sanford mentioned her activities with her church and the EWMC. She gave us an opportunity to discuss what we could do to decrease the isolation and depression experienced by some seniors. Sister Sparks spoke on the challenges young people face and urged us to continue mentoring the next generation so that they will have the knowledge to make the necessary changes to secure the security of labor and all working people. President Emeritus Lucy asked us to share our wisdom and experience, mobilize our community (particularly when it comes to the vote), reminding us that we must continue to be involved. He also encouraged us to speak with our local legislators and the importance of being knowledgeable on the issues when doing so; noting that what happens in our community is no accident.

Sister Elise Bryant, Executive Director of the Labor Heritage Foundation, entertained us with song and stories of the work of historical labor union activists, including her own and reminded us that we are the ones who can make the difference.

Our final presenter, Clifton Denby, Field Representative with the Baltimore Teachers Union and Certified Holistic Health Consultant, informed us on the hidden dangers of cell phone use, the importance of drinking water, understanding medical test results, side effects of prescription drugs and equally important, exercise.

Overall, our conference was inspiring, informative and uplifting. In a time when so many have forgotten the work done by those who came before them, we are thankful that CBTU continues to acknowledge the importance of participation and we appreciate the efforts of our chair, Donald Afflick and conference coordinators, David Claxton and Carolyn Williams in creating one of our best conferences to date.






Local 685 Conservation and Recreation Committee Anna Cook, Chair


