LABOR DAY BLACK OUT & HOLIDAY QUALIFYING DAYS

As a reminder, in accordance with the provisions of Document 8 of the UAW/GM National Agreement, the use of VR hours will not be permitted, unless excused in advance, on Holiday qualifying days. Therefore, Friday, September 3rd, 2021 is a Black Out Day and Tuesday, September 7th, 2021 is both a Black Out and Qualifying Day and September 8th is just a significant day in history. Employees not previously approved to be off on these days cannot cover their absence with VR and are subject to the next step in Document 8 of the National Agreement attendance procedure.

PERFORMANCE BONUS PAYMENT

Pursuant to Paragraph 101 of the 2019 UAW-GM National Agreement, a performance bonus payment equal to 4 percent(4%) of Qualified Earnings will be paid out to eligible employees on the week ending October 17th, 2021. The eligibility date is September 20, 2021.

An employee shall become eligible for a Performance Bonus payment as hereinafter defined, provided the employee has seniority as of the designated eligibility date set forth above.

The employees Performance Bonus will be based on the qualified earnings during the 52 consecutive pay periods immediately preceding the pay period in which the designated eligibility date falls.

APPENDIX A TRANSFERS
